1 Data protection statement for members and supporters

1.1 Introduction

This privacy notice explains how the European Dodgeball Federation (EDF) handles and uses the personal data it collects about affiliated players, individuals involved with the running of its activities and staff hired for the running of competitions. When collecting this information, EDF acts as a data controller and will therefore provide below, in line with the General Data Protection Regulation (GDPR), all necessary information on how it collects personal information about you, the purpose for which it is used and how you can interact with us.

1.2 Scope

We are committed to protecting your personal information and being transparent about what information we hold. In light of the General Data Protection Regulation enacted by the Data Protection Bill 2018, we have updated this policy to set out the steps taken to ensure your privacy is upheld. As a legal basis for compliance under GDPR, we collect consent from members to conduct our processing activity. The following notice sets out how EDF uses personal data to carry out its operations.

2 Who we are

2.1 The European Dodgeball Federation

The European Dodgeball Federation (EDF) is the continental governing body for all national Dodgeball organisations in Europe. Among its goals are supporting and promoting growth of the sport of dodgeball in our member nations and delivering international championships.

2.2 Data Protection Officer

EDF has appointed a Data Protection Officer to ensure compliance with all aspects of the GDPR, who reports to the EDF's Legal Head of Department. The Data Protection Officer oversees how the organisation collects, uses, shares and protects your information to ensure your rights are fulfilled. 3 Personal data held by EDF

The majority of data held by EDF is provided by the national governing bodies of dodgeball in its respective member nations.

Data belonging to players involved in competitions organised by EDF, is provided by the member nations and contains:

- Player names
- Player dates of birth
- Player contact details

International eligibility data is collected for players representing nations in competition. This may include:

- Photocopies of passports
- Photocopies of proof of address
- Photocopies of birth certificates
- Photocopies of family members' documentation if claiming eligibility through family connection



Other data collected and retained for international players includes:

- Player names
- Player dates of birth
- Player contact details
- Records of consent to record the data
- Records of the method of proof of eligibility

Data belonging to volunteers involved in the running of EDF is collected from those individuals and contains names and contact details.

4 How long we keep your information

To meet our legal and regulatory obligations, we hold player information from the date when international squad data is submitted for competition by a member nation to EDF up to a maximum of five years after a player's last appearance in international competition. This period of retention is to minimise the need for resubmission of documentary proof of international eligibility in the event of players returning to international competition after a period of absence.

Documentary proof of international eligibility is only retained for the period of reviewing to verify eligibility. It is never held for more than one year.

5 How we use your data

Player data is used to record participation in and eligibility for various competitions.

6 How we protect your data

EDF ensures it has appropriate data sharing agreements in place before using your personal data. EDF will never share your data with a third party without prior agreement in place relating to protection of your data and without evidence of the third party's compliance with GDPR.

Any transfers of your data outside of the European Economic Area, for example to an international dodgeball organisation, as set out above, are protected either by an 'adequacy decision' by the European Commission (declaring the recipient country as a 'safe' territory for personal data) or by standard contractual clauses adopted by the European Commission (which give obligations for the recipient to safeguard the data).

7 Your rights

Under the General Data Protection Regulation, you have the right to:

- Be informed
- Access information
- Rectification
- Erasure
- Data portability
- Object to processing of personal data
- Restriction
- Object to automated decision, including profiling

7.1 Your rights over your information



You can at any time request a copy of the information EDF holds about you. You may also correct it if it is inaccurate. You can additionally request us to stop using your information. This request can be lodged with any council member of EDF or with the Data protection Officer. When exercising this right, you will be asked to file a Data Subject Access Form, which will be made available to you by EDF, to ensure the request will be handled within a set timeframe and respecting the current legislation.

7.2 Your right to complain

If you have a complaint about the use of your personal information, please let us know and we will take the appropriate actions to rectify the situation.

8 Further information

We always handle your personal data securely and minimise its use, such that there is no overriding prejudice to you by using your personal information for these purposes. In addition, there is no statutory or contractual requirement for you to provide us with any personal data.
